- **Jan Kimball-** There was some confusion that needs to be cleared up. Jan Kimball has done an excellent job as our Town of Hoosick Court Clerk working with the Town Board, Justice Restino, Justice Whalen and Justice McClellan. Justice McClellan has already acknowledged what an asset Jan has been in the transition. Jan in the past has expressed interest in becoming a justice in the Town of Hoosick and the discussion was had with her after Judge Whalen passed away. Jan knew that Justice McClellan was interested and that he would make an excellent Town Judge. Jan is still interested in one day becoming a Town Judge but felt the timing was not good considering the circumstances.
- **Bouncelinx-** Welcome John Carnett from Bouncelinx as we follow up from the Special Meeting held last week in reference to Town Wide high speed internet service. Bouncelinx is a private business. They are requesting the Town give them a 3 year tax abatement on its fixed wireless distribution system with the first 100 customers getting free installation. The Town Board supports Bouncelinx and feels it's very important to get wireless service to everyone in the community, but they need to look further into the tax abatement request. The Town Board will hold a Public Informational Session on May 20th Wednesday between 5:00 pm and 8:00 pm. A notice will be put in the newspaper and on the Town website.

Town Council Reports

Jeff Wysocki: working on the Ag Stewardship program with the Philpotts. Federal money has not been received.

Bruce Patire: Reviewed all of the Town's insurance policies again and rate went down \$64.00. Workers Comp not going up.

Personal Tribute to Tom Vasello who passed away recently. He was one of the most dedicated people in working with the Little League for many years. A Moment of silence in honor of Tom Vassello

Dave Sutton: talked with Ken Lorenze about the possibility of building cement wall at the athletic field for LaCross practice. Working with Judy Quackenbush in regards to the engraved brick fund raiser for the pool.

Jenn Hyde: reported the Village clean-up day was a huge success about 300 people

Old or Ongoing Business

- **Castle Playground-** Parkitects completed the Playground Maintenance Audit & Safety Inspection. We are waiting for the report. Kiwanis will use the report to create a rehab plan and schedule.
- **Pool Rehab Project-** The crack sealing injection process has been completed and we have been told there is a 7 day curing process so Watson Co. will not be at the pool working the week of 5/11. The majority of construction work has been completed. When Watson Co. returns next week they will begin applying the Gunitite to the pool surface.
- **Pool Pumps & Pipes-** Issues have come up with the pool pumps (need replacing) and some broken water line pipes. Pumps are on order; pipes are in the process of being repaired. This is not a part of the Pool Rehab Project but will be a part of the Grant Funding Upgrade Project that we hope to do in the fall, so we are doing just what is needed to get us through this summer.
- **Computer Server-** Is here, Bob Nesbit will be setting it up.
- **Consolidated Funding Grant-** For the project to update the Pool Mechanical Room (pump house) and the bath house. LaBerge has put together all of the information required and sent it to NYS Parks & Recreation. We are waiting on approval to enter into the Funding Contract.
- **Updating Purchase Policy & Investment Policy-** We continue to look at these policies that were last updated in 1999.
- **Building Inspector/Code Enforcement Officer Position-** This is a part time position requires approx. 3-4 hours per day, 3-4 days a week, some call in time, mandatory training required, with a budgeted annual salary of \$14,752. Second application received, will be conducting interviews.
- **Basketball Summer Camp-** High School Teacher & Coach Chris Fleming is going to run program through the school.
- **Union Agreement-** with our highway workers expires at the end of the year. We will need to hire Attorney to represent the Town. We will also need a committee to work on this.
- **NEW LED Lights on the Church St Bridge-** The LED lights we authorized purchase of last month have been installed by the Hoosick Falls DPW. Thank you to Neil Stowell & the Village Crew for doing this for us.

New Business

- **Resolution #62, 2015 The Town of Hoosick has received \$300 donation from S. Stanislaw Society for the Pool Slide and a Budget Modification is needed.**
Motion to Approve
Sutton made the motion to approve Re. #62, 2015, Wysocki seconded, roll call vote: Hyde: aye, Sutton: aye, Patire: aye, Wysocki: aye, Surdam: aye. Motion Approved.
- **Union Attorney-** Discussion to go with our Town Attorney Firm of **Tabner, Ryan and Keniry, LLP** (Bill Ryan does Teamsters Negotiations regularly) @ \$180 per hr. or to go with **Roemer Wallens Gold & Mineaux LLP** (Elayne G. Gold, Esq. is who we worked with previously) @ \$220 per hr. for Elayne & Partners & \$190 for Associates.
Discussion: Sutton was in favor of Tabner, Ryan and Keniry, they represented the school in the Teachers Contract and did a great job. Patire and Wysocki both said Our Town Attorney does an excellent job but felt there should be a different attorney for the Union in the event an issue arises with Our Town Attorney and it becomes a conflict. Hyde said Patire had a valid point but was still in favor of Tabner, Ryan and Keniry.

- **Resolution #63 Authorizing Supervisor Surdam to enter into an agreement with Tabner, Ryan and Keniry, LLP to represent the Town of Hoosick in Labor Negotiations with Teamsters Local 294.**
