# XII. Old or Ongoing Business

- **Boundary Line Adjustment Update- Castle Playground Project-** The field work has been completed. We will be setting up a meeting with surveyors in the next couple of weeks to determine where the boundary lines are to be positioned.
- Castle Playground Project- Kiwanis, working with our highway dept. has removed large sections of the old wooden structures and the old swing set. The order for the new equipment has been placed. We expect delivery of the new equipment in very early spring.
- **Pool Project Phase Two-** In the next few weeks we will be starting the planning for upgrading the Bathhouse & the Mechanical Room.
- Cipperly Road Extension- Resolution to declare as abandoned pursuant to New York State Highway Law Section 205, subdivision 1 and to authorize Highway Superintendent Shiland to remove from Town of Hoosick Highway Inventory.

- Well Water Testing- We have been working with NYS Dept. of Health on testing private wells for PFOA's in the area. We are expecting results from 12 Samples that were taken in November as soon as this week. The NYS Dept. of Health was in the area last week to collect a few additional samples in the area.
- Local Law #4 of 2015 This Local Law No. 4 of the Town of Hoosick shall be known as "Real Property Taxation for Certain Solar or Wind Energy Systems or Farm Waste Energy Systems." A public hearing was held 12/28/15. The vote on the law was tabled the same night in order to obtain additional information and to request the NYS Attorney General's Office offer an opinion in reference to this proposed law. Set a Date- to schedule another Public Hearing on this proposed law and to continue the discussions of our options.
- Commercial Solar Farms- In all of our discussions no one seems to be against Solar Energy. The concerns are being generated by the proposed Commercial Solar Farms and the impact they are/will have on our town. We had a public meeting in August 2015 where the idea of a solar moratorium was soundly rejected. **Discussion-** To propose a solar moratorium on Commercial Solar Farms.
