Assessor's Report

Tony was watching the meeting. Nothing really to go over at this time.

Superintendent of Highway's Report

• **Beck Road**- The board discussed paving only a portion of Beck Road or if it would be more cost effective to pave the entire road. Supervisor Surdam stated that there is money to move around from the equipment fund and DB fund to do the entire road. The board agreed to do the entire road as this seemed to be the more cost effective way.

Town Historian

• Phil stated that the Museum is now open every day from 11-2. The Museum is featuring Local Artists. On July 16th the museum had on display Barbara Gifford paintings. August 16th the 242nd Battle of the Walloomsac will be held at 4pm. August 20th there will be photographs by Donny Betit for purchase from 4pm-8pm. Chenette Brown from Schenectady may be featured in September. A professor of Delaware Valley Agriculture came to see the Walter A Wood Machine on display at the Museum. He is teaching about this particular

machine in his class. Councilman McAuliffe will be discussing the "Purple Heart" presentation that was on August 7th. There were 78 people who attended.

Recreation

Pool & Summer Camp Reports- Kim Brownell stated that the pool lifeguards had a night
where they worked on scenarios' at the pool using their learned lifeguarding skills. All did
well. Swimming lessons are going well. All of the patrons like the early morning start at 7:30
for Adult morning swim. Pool admissions have been down this year and COVID has affected
this.

Ashley updated the Board with the Camp report. Everything seems to be going well. No issues thus far.

 Additional Pool Appointments- Lifeguards Matthew Hart & Daniel Hunt MOTION

McAuliffe made the motion to approve the 2 additional lifeguards to finish out the two weeks for the pool. Sheffer seconded. All ayes carried.

- We did receive our Camp Permit & have had our 1st Camp Inspection- The camp inspection went well there were no violations. The permit was issued.
- WSI Class- Class is all set for the last weekend of August at the pool.
- **Pool Handicap Lift-** The board discussed the Handicap lift at the pool. Supervisor Surdam stated that the battery is the only thing that needed to be replaced. You cannot just buy the battery and you needed to by the battery and receiver which the cost was \$1,400. With only two weeks left at the pool Supervisor Surdam thought it would be a good idea to wait to see if the pricing would come down for this.

Supervisor Surdam's Report

- Worked on the monthly meeting agenda and meeting prep.
- Spoke at the Purple Heart Ceremony held in the Village Park.
- Daily pool maintenance.

Town Council Reports

Deputy Supervisor Sheffer- Eric and Bill met with Marianne and Rick regarding the armory lease agreement. This is just at the beginning stages. The Water meeting met this past month. The people are looking for information on the health studies that were conducted and the water source that will be used for the Village. This will be discussed at the next meeting.

Councilperson McAuliffe- Jerry attended the Purple Heart presentation and stated that it was well attended. Jerry also stated that the trains coming through are slow. There is a piece of the track that is still a big concern and looks very dangerous. Supervisor Surdam states that they are inspecting the track twice a week to make sure that there are no issues. Bruce Patire contacted the train representative and asked for a copy of the report. He was told that they will get back to him. Senator Jordan, Assemblyman Jake Ashby (Tom) and Peter who is the Veteran Rep for Rensselaer County were all present for the Purple Heart presentation.

Councilperson Hanselman- Manchester Carpet Care cannot help with racking the turf. He does not have the proper equipment to rack the turf and it would be costly to get the proper attachments to do the job properly. Bill will have to work something else out to get the turf racked before winter.

Councilperson Houghton- Nothing at this time. The Town of Hoosick Hand Book was discussed and Supervisor Surdam had questions regarding some of the information in the handbook. There is a workshop set up for discussion on the handbook on August 24th at 6:00pm

- Phillip Wofford Painting- Supervisor Surdam was not sure who to call regarding the painting.
 He was in contact with the Historical Society and Marianne but neither wanted it. Sheffer made the suggestion to contact Civicure regarding the painting.
- 2019 Hoosick Historical Society Annual Report for 2019 is available. Joyce provided the report to Mark.

Old Business

- **On-Line General Town Code-** Laws have all been sent to Jonathan for review and to forward to appropriate person. There are some laws that will need to repealed.
- **2020 Census- Census workers will begin knocking on doors soon.** Supervisor Surdam states that only 60% of the people have responded to the census. There will be Census workers coming around to the ones that have not answered the questions to the census.
- Updating Land Use Law Commercial vs. Personal Use- Sheffer stated that he had a lot of
 questions regarding the way the answer was worded and stated that if the vote needed to
 happen tonight his would be no. The board further discussed and decided to table the
 acceptance until further clarification could be obtained.
- New Town of Hoosick Employment Practices Manual & Compensation & Benefits Manual-Motion to approve- There is a workshop scheduled for August 24th at 6pm.
