The PV system is sized to generate 5.0 mW (dc) and will occupy a project area of approximately 19 +/- acres on the 99.52 +/- acre 469 Wilson Hill Road parcel. The total disturbance on both properties equals 27 +/- acres. The only development on the 443 Wilson Hill Road includes the interconnection and related maintenance road. The project will involve the construction of a fixed tilt solar array that will utilize central inverter and transformer equipment all to be accessed by gravel service roads. The solar array will connect to the existing electrical grid along Wilson Hill Road.
